LINDUSTRY ENGAGEMENT, EDUCATION, AND TRAINING

Services Services

We can work with you to facilitate virtual or in person meetings and events using our no-cost model, which means that there is no fee for our service for the Government. The vast majority of events we work on are conducted using a customizable MOU to serve as the formal agreement of roles, responsibilities, and deliverables for NCSI and the government. These no-cost agreements state that NCSI will coordinate all logistical aspects of the event at no cost to the government hosting organization, and is able to recoup the costs incurred by producing and executing the event by charging attendees, sponsors, and exhibitors. The fees cover items such as event production, overhead, logistical support, supplies, NCSI labor hours, etc. NCSI's business model was actually used as a case study for GAO Ruling B-308968, which validates our no-cost model as a legal and fully permissible means by which any Federal agency may produce an official event. We also have a no cost option on our GSA contract that is available for use by all government agencies.
